



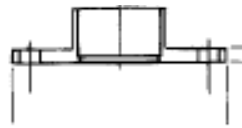

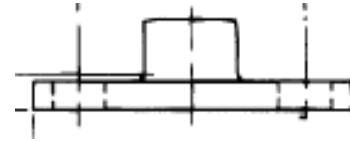

## CONDITIONS OF SALE

**PRICES:** All prices and conditions are subject to change without notice and all quotations, unless otherwise specified, are binding only for immediate acceptance. Published prices are based on material made to EPC's standard tolerances and dimensions. All orders are subject to acceptance by the home office. Orders accepted will be on the basis of price in effect on the date of shipment.

**TERMS:** Net cash 45 days, or 2% discount allowed for payment on or before the 35th day following the date of shipment.

**FREIGHT:** Freight will be allowed on single shipments of 600 pounds or more to any one destination in the United States, except Alaska and Hawaii. However, two or more orders, may be combined in one shipment for freight allowance. On freight allowed shipments the consignor reserves the right to control the routing and use the route having the lowest published rate.

**RETURN OF GOODS:** No material is to be returned without our written permission. A minimum handling and inspection charge of 25% will be levied on all approved returned goods, plus transportation charges both ways.

## WARRANTY

Elkhart Products Corporation warrants that all fittings will be free from defects in material and workmanship which will impair their usefulness provided they are used in the service for which they are recommended. Any fittings which proves to be defective will be replaced or a credit issued but no incidental labor charges, expenses or damages will be allowed.

### PART B

Except as expressly stated on this document, Seller shall not be liable to the Buyer or to any other person, firm, or corporation for any incidental or consequential loss, damage, or injury arising out of any breach of warranty or any other act or default relating to Buyer's order or to product or services provided to Buyer, even if any such loss, damage, or injury is caused by Seller's negligence.
