CONDITIONS OF SALE

PRICES: All prices and conditions are subject to change without notice and all quotations, unless otherwise specified, are binding only for immediate acceptance. Published prices are based on material made to EPC's standard tolerances and dimensions. All orders are subject to acceptance by the home office. Orders accepted will be on the basis of price in effect on the date of shipment.

FREIGHT: Freight will be allowed on single shipments of \$1,500 net or more to any one destination in the United States, except for Alaska and Hawaii. However, two or more orders may be combined in one shipment for freight allowance. On freight allowed shipments the consignor reserves the right to control the routing and use the route having the lowest published rate.

RETURN OF GOODS: No material is to be returned without our written permission. A minimum handling and inspection charge of 25% will be levied on all approved goods, plus transportation charges both ways. Returns will not be accepted for bagged product that has been opened.

WARRANTY

Elkhart Products Corporation warrants that all fittings will be free from defects in material and workmanship which will impair their usefulness provided they are used in the service for which they are recommended. Any fitting which proves to be defective will be replaced or a credit issued but no incidental labor charges, expenses or damages will be allowed.

LIABILITY POLICY

PART A

Except as expressly stated on this document, Seller shall not be liable to the Buyer or to any other person, firm or corporation for any incidental or consequential loss, damage or injury arising out of any breach of warranty or any other act or default relating to Buyer's order or to product or services provided to Buyer, even if any such loss, damage or injury is caused by Seller's negligence. The correction of defects as provided in the warranty statement above shall constitute Seller's full obligation with respect to all claims and Seller's liability shall in no event exceed the unit purchase price of the product in question.

Any lawsuit or other action based upon breach of this contract or upon any other claim arising out of this sale (other than an action by Seller for any amount due to Seller by Buyer) must be commenced within one year from the date of the tender of delivery by Seller or, in the case of a cause of action based upon an alleged breach of warranty, within one year from the date within the warranty period on which the defect is or should have been discovered by the Buyer.
